4. All information obtained by the Orange County Council, BSA will not be disclosed for any purpose not related to employment.
5. I agree to participate in any drug testing processes that may be adopted, and to support the Boy Scouts of America's policy of a drug and alcohol free camp.
6. The Boy Scouts of America maintains that no member can grow into the best citizen without recognizing an obligation to God and, therefore, acknowledges the religious element in the training of the member, but it is absolutely nonsectarian in its attitude toward the religious training. It is policy that the organization or institution with which the member is connected shall give definite attention to their religious life. Only person willing to agree with this declaration of principle and the Bylaws of the Boy Scouts of America shall be entitled to certificates of leadership.
